# GENERAL INFORMATION AND REGULATIONS

#### 1. The date, time and place of display

- (1) The date of display
- On October 18, 2018 (Thursday) to October 20th (Saturday), a total of three days.
- (2) The time of display

On October 18th (Thursday) to 19 (Friday) daily from 9:00 am to 5 p.m. October 20<sup>th</sup> (Saturday) from 9:00 am to 4 p.m.

- \* Exhibitors enter the show in advance: 8 am on October 18.
- \*Exhibitors enter the show in advance: 8:30 am on October 19-20.
- (3) The place of display

One floor of A area and two floor of H area in Taipei World Trade Center exhibition hall

## 2. The entry, time and attentions of the exhibits

# 3. Precautions for exhibitors entering and leaving the field

(1)

- 1. When entering and leaving the market, trucks are allowed to enter the exhibition. Vehicles entering the exhibition hall are required to follow the prescribed route (please refer to Enclosure 26, Vehicle Entry and Exit Roadmap).
- 2. Using the exhibitors in Zone A of the first floor of the Exhibition Building (1 Hall), please enter the exhibition hall by the organizer's personnel in order from the entrances of No.15 and No.16 in Area A.

(2)

1. In order to ensure the safety of the structure and floor of the exhibition building, the total

weight of the vehicle in and out of the exhibition vehicle is above 15 tonnes (with the car body or the driver license), and the application form of the World Trade Center heavy truck should be completed by the online application system, and five groups of applications are presented to the exhibition office of the foreign trade association 15 days ago. If the vehicle with a total weight of 15 tons or more, the certificate of proof within 24 hours is required to be admitted into the operation within the permitted period after the approval of the Trade Association Exhibition Management Group. The field 6 in Fifth articles (1) for the general provisions of the decoration operation of the Trade Association Exhibition.

- 2. In order to maintain the air quality of the exhibition field, the crane (including crane card) will be used by the manufacturer to fill in the application form for the admission operation on the line system for 2 working days before entering the field. For the relevant fees, the seven field in fifth articles (1) of the "general provisions of the decoration operation of the exhibition field of the foreign trade association" (http://www.twtc.com.tw/db/images\_g1/m1.doc).
- 3. The diesel engine height limit: in principle, there will be no more than 4 stacking operations at the same time.
- 4. Applying for the entry of the car in advance, please complete the application form to the online system for the entry of the world trade center, and refer to 8 and sixth of the fifth articles (1) of the "general regulations of the decoration operation of the exhibition field of the foreign trade association".
- 5. During the layout and removal of the exhibits, the passenger cars are not allowed to enter, and the trucks should be allowed to enter the field where should follow the prescribed route and leave the field as soon as possible in one hour so as not to obstruct the corridor. Each exhibitor is limited to one vehicle, and the organizer will register its entry time, car number, owner's stall, and the person in charge when the vehicle enters the field, and will receive NT\$1,000 for the entry margin of the vehicle. When the vehicle enters the exhibition hall, the original number of the deposit will be refunded within one hour, and the extra time will be charged at NT \$200 per hour.
- 6. The vehicles are arbitrarily parked to obstruct traffic and, after being advised to ignore the traffic, which will be regarded as exhibitors, and the exhibitors belonging to the vehicle (including the decorators) will be identified and prohibited to participate in the next exhibition.

Be sure to complete all the booth decoration and display work before 5 p.m. on October 17th. During the entry period, if the arrangement is completed ahead of schedule, please send the staff to take care of the booth so as not to lose the exhibits.

# 4. Precautions during the exhibition

- (1) During the exhibition period, no large exhibits will be allowed to be transported into or out of the exhibition hall.
- (2) The exhibitors should insure their own products and upholstery materials for their own insurance. During the exhibition period (including the pre show arrangement and the dismantling after the dismantling), the exhibitor should take all responsibility for any loss of property.
- (3) All products which have not been approved by the government are prohibited from being exhibited at this exhibition hall.

- (4) During the exhibition period, no person shall occupy the aisle or place objects in public areas except for the organizers, and it shall not distribute any publicity materials outside the booth. In case of an item placed in a violation, the organizer is able to immediately remove or confiscate the item, it can not to bear the responsibility for custody and the return of the original, also it can remove the cost derived from the owner of the item.
- (5) When the exhibitor makes a noise (more than 85 decibels), dust, stink or the obstruction of the aisle during the operation of a site machine or a publicity campaign during the exhibition, the exhibitor may take a stop when the sponsor is advised to be ineffective or ineffective when it is ineffective. The supply of water or electricity is prohibited or exhibitors are prohibited from exhibiting.
  - (6) The publicity activities during the exhibition:
- 1. The exhibitors should hold an application in advance during the exhibition. The activities should be held only within their own stalls, not the public walkways (or public areas), nor the dissemination of the documents outside the stalls, and the unimpeded responsibility for the maintenance of the aisle. If the public walkway is occupied (or the public area), it is not improved after persuasion. In addition to the confiscation of the deposit, the organizer will prohibit the activity from continuing in the period of the exhibition.
- 2. On the basis of safety and Exhibition order, the exhibitors will be responsible for their own legal responsibilities and it should avoid any activities or actions that are harmful to others (such as throwing gifts or souvenirs, etc.). In case of a violation, no improvement has been made after the cancellation of the record by the inspection group of the exhibition. In addition to the confiscation of the deposit, the exhibitor is prohibited from continuing to hold any activities during the exhibition.

#### 5. Exhibitor identification certificate

(1) The exhibitor's identification card: The card is used forthe entry and exit identification of the exhibition hall during the exhibition period, and it can lease 2 booth (except for the package manufacturer). When exhibitors enter the field in from October 18th to 20th, they will receive it at the conference reception. Exhibitors are required to wear this card during the entry and exit period and the exhibitors will not be allowed to enter the exhibition hall.

1. The booth rented by the exhibitor is only space (without any stall equipment) and it has to decide to entrust the upholstery contractor or other decorating contractor to undertake the decoration works. The fees paid by the exhibitor are included in the basic upholstery booth (Enclosure 1). When the basic upholstery equipment is required (Enclosure 2), it must be leased to the decorating contractor who provides the basic upholstery stall.

- 2. The exhibitor must pay attention to the relevant regulations provided by the contractor or other decorators for the return of the order and the time of payment, and to confirm the requirements with the decorators to avoid disputes.
  - (2)Instructions for the specification of decoration

In order to ensure that the builders in and out of the exhibition field know and abide by the rules of the world trade fair during the construction period, from January 1, 2015, all the upholstery manufacturers who want to enter the construction of the world trade exhibition hall are required to wear the exhibition site service certificate issued by the foreign Trade Association. In order to maintain the construction safety of the exhibition, all the schools are invited to supervise all the students participating in the exhibition and entering the exhibition field to assist the participants to see the "safety notice of the exhibition place of the foreign trade association".

Exhibitors must abide by the decorating regulations of foreign trade association and the relevant occupational safety and health regulations of foreign trade association, the safety and hygiene regulations are downloaded: <a href="http://www.twtc.org.tw/Member.aspx">http://www.twtc.org.tw/Member.aspx</a> \* the specifications of the detailed exhibition decoration must refer to the exhibition handbook, the general regulations of the Taipei professional exhibition of the foreign trade association and the specification for the decoration work of the exhibition venue of the foreign trade association. All schools should cooperate with the decorating factory. Business must abide by the relevant regulations of the labor inspection office of the Taipei municipal government labor safety manual.

- (3) The height of booth in A area: is limited to 4 meters (including identification signs), and the exhibition prohibits 2 floors. The height of booth in H area: 2.3 meters (including identification signs).
  - (4) The booth should not be suspended in a balloon
- (5) For the exhibitors, If they want to decorate the column of the walkway in the upholstery (It only limited to the exhibitors floor one in Taipei World Trade Center), fill it (Enclosure 10), and send it to the office window before August 20th with the design map of the appendage stall (containing flat, facade), if overdue, it will not be accepted, and the key points are as follows:
- 1. The application is limited to the application of the exhibitor in the stall (that is, the area of the column is partly in the stall and is to be decorated partly in the aisle).
- 2 If the exhibitors need to decorate the walkway packing columns, they must have the construction permission before they can perform the beautification of the packing columns. The method of packing column:

The outer rim of the packing column is below 30 cm from the cylinder.

- (1) The fire box (wide of 94 cm, high of 126 cm)and extinguisher box (wide of 65 cm, high of 75 cm) should not be closed.
  - (2) Do not close the electric box (60 centimeters wide, 136 centimeters high).
- (3) The wall of 60 cm high and 60 cm wide should be set up on the new wall panels, so that the wall has both exhaust blinds and equipment.
- (4) The air detector must be exposed, and the front wall can't be obscured by the partition wall or any object. The detector—one is 15 cm wide, 15 cm high, 2 detectors (30 cm wide, 15 cm high), 3 detectors (45 centimeters wide, 15 centimeters high) and 15 cm in each of the detectors.
- (5) The height of the cladding wall is not higher than 4 meters. If you want to be above 4 meters, you must apply for extra high buildings. If the above-mentioned regulations are violated,

the person who has not been improved immediately after the notice, which will be punished by the exhibitor at 5000 NT dollars and will be dismantled. The cost of the dismantling will be held by the exhibitor; if the fire and related units open the ticket, the fine and the related liability shall be responsible for the manufacturer. The construction unit will be punished according to the seventh provisions of the general regulations for decoration work of the exhibition hall in the foreign trade association.

- 3. Before the completion of this procedure, we will have to remove the column decoration of the relevant temporary walkway and replace the cost of clearing.
  - (6) The roof for the back wall and the beautification

Facing the wall of the aisle, the back wall, the back of the sign must be beautified, or the height of the exhibition board of the adjacent stalls is not a moment, the higher manufacturers also have to handle the back of the exhibition board. It is suggested that it should be coordinated with the neighboring manufacturers in advance, and the construction will be obtained after the agreement, so as to avoid the difficulties and disputes between the schools.

#### 8. Hydropower facility

- (1) The conference will provide 500 watts of electricity (110 volts) for each booth (500 watts for each stall, which accumulated at the booth number) and there is no extra charge. Each three stalls provide a two socket attached switch socket, and less than three persons also provide a two socket attached switch socket. For 24 hours of power supply (such as refrigerators or special displays), or exceeding free accumulative amount of electricity (110 volts 500 watts) or using 220 volt electricity and water users, applications and fees are required and paid (for reference (Enclosure 8 to enclosure 6).
- (2) please make sure to fill in the "position chart of the hydropower station". The water and electricity of the general assembly that have not been sent back to the conference before the deadline, which will be constructed directly, and if the temporary change in the field will be charged.
- (3) During the entry and exit period, only 110 volt outlet power will be supplied on each big column of the exhibition site, and it will be provided for booth decoration and layout, but there is no booth lighting and power supply will be provided.
- (4) The day before the exhibition (October 17th) will be full power supply at 8 a.m., and the power supply is closed at 5 p.m. (extension of the use or special exhibition time for another application). Only those who have not completed the application procedures for power supply will not supply the power supply for the time being. No electricity supply for booth lighting will be provided during the rest of the season.
- (5) During the exhibition period, the power supply time of the exhibition is from 10 am to 5 p.m. (Last day to 5 pm).
- (6) In order to protect the safety of electricity for special exhibits, exhibitors will install voltage stabilizer or power supply system on their own if necessary.
- (7) The exhibitors must be responsible for their own electricity and pay all the fees for retransmission if the actual electricity consumption exceeds the electricity consumption.

#### 9. Applying for temporary telephone, broadband internet and TV broadcast

- (1) China Telecom Limited by Share Ltd accepts exhibitors from the exhibitors to apply for temporary telephone calls or rent temporary broadband network (ADSL). Please contact the company's eastern operation Office (address: No.130 of 11058 Taipei song Ren road, telephone: 02-2720-0149) or access to the exhibition handbook (enclosure 18, 19) before September 15th.
- (2) Before 4:30 pm of the end of the exhibition day (October 20th), the manufacturer will be asked to hand the telephone to floor one of China Telecom temporary service desk and go through the procedure of returning the machine. Before the procedure is done, please keep the phone on its own, so as to avoid the loss.
- (3) Applying for other communication lines (ISDN, data lines), please contact the relevant unit of China Telecom Company: 0800-080-858.
- (4) Internet access is restricted to the first floor of the exhibition building of the Taipei World Trade Center, the H area of exhibition hall in floor two, the conference room in floor two and the restaurant in floor two.
- (5) It only provide clients and exhibitors to receive and receive basic services such as e-mail and web pages. If you need to use the Internet for a long time or download a large amount of information, please apply for another ADSL.
- (6)When using this service, you should be sure to carefully protect your company (personal) information security and privacy, in the event of business losses or legal disputes, please be responsible.
- (7) The main points of the television wall and the large fluorescent curtain wall are as follows (enclosure 11):
- 1. From the ground to the highest point of TV, which is less than 2.5 meters, the front must be one meter above the baseline of the booth.
- 2. The same as above, from the ground to the highest point of TV >2.5 meters (maximum not exceeding 4 meters), the front must be two meters away from the baseline.
- 3. The anti dumping facilities should be set up on the TV wall (with side support, fixed steel cable and nylon rope), and the base must be coated with steel plate. When the earthquake is shaking, it avoids the uneven force and causes the collapse.
- 4. The screening of films must conform to the theme of exhibitions or activities and it must not violate good customs.

#### 10. Setting up stage, sound, balloon equipment in the stall

(1) Please refer to enclosure 13 and enclosure 14. Exhibitors may not handle related activities without prior application for deposit.

## 11. Application for license of vehicle and joint vehicle

(1) For large trucks of 6.5 tons or more and connecting vehicles, please complete the "Taipei City Police Department Large Truck and Linked Vehicle Pass Application" (such as enclosure 22) and send it to Taipei City before September 15th. The Administrative Police Traffic Brigade Administration Group (26 Ai Nian West Road, Zhongzheng District, Taipei City) will pass the application to the exhibitors after the application is approved. The junction car is submitted in the same manner as above. Please refer to the Internet at <a href="http://td.police.taipei/">http://td.police.taipei/</a> for the application procedures for the control of vehicles, time slots and passes for large trucks around the World Trade Center in Taipei.

#### 12. The key considerations Booth design and site construction

Please read the general specification for the decoration operation of the Trade Association (www.twtc.com.tw/db/images\_g1/m1.doc) and the general specification for the Taiwan professional exhibition (www.twtc.com.tw/DB/images\_G1/book.pdf).

If there is a violation of the provisions for the decoration of the foreign trade association, the trade association will not supply power supply, such as causing damage to the facilities or casualties, and it shall be responsible for the compensation and liability of the exhibitors and contractors who violate the rules and regulations.





# **General Regulations for The Installation Of Stage and Sound**

# **Equipment In Stalls**

- 1. The outer edge of the stage must be more than 2 meters away from the aisle border, the number of speakers is limited to 2, and it must face its own stall and keep the corner, the volume must remain below 85 decibels; Adjacent stalls are not allowed to perform stage activities or play audio at the same time. (Each unit should be scheduled for more than 1 hour intervals, 15~20 minutes per time).
- 2. The organizer has the right to dismantle or dispose of electricity from the booth without authorization.
  - 3. The applicant must pay a deposit of NT \$50,000 (spot check).
  - 4. The violation will be dealt with in three stages:

The First violation: If the volume of volume is more than 85 decibels or other irregularities, the sponsor will impose a fine on the exhibitor if it is persuaded not to be on the spot, that is to open a warning form and indicate another violation.

The second violation: After rechecking the above violations, they are fined at the beginning of the notice: NT\$1,000 for the first time, NT\$4,000 for second time,NT\$10,000 for third time,NT\$15,000 for forth time and NT\$20,000 for fifth time.

The third violation: If the exhibitors refuse to improve, and the cumulative number of fines is 5 times, the power of the booth will be stopped.

- 5. Otherwise, as a result of the construction or operation of the decorators or sound dealers, the General Assembly will have the seventh provisions in accordance with the exhibition decorating operation: Disposal by violation.
- 6. The method of volume measurement: The decibels are measured from 1.2 to 1.5 meters from the ground or floor, which close to the height of the human ear; the location of the measurement is measured at the position of the sound source at the horizontal distance of 3 meters.




# APHRS 2018 Hospitality Area Plan


